Agreement to rent with an option to purchase an Exactrix Mustang Tool Bar.

- 1. Exactrix to supply a 2018 model year 3 section Mustang 7 x 7 Tool Bar, Lift Assist on 120 inch spacing with positive down pressure and quantity 24 Mustang Openers in a double rank with average row spacing of 15 inch. The tool bars is equipped with ballast tanks, a 12 ton trailer heavy hitch and hydraulic winch for trailers.
- 2. Exactrix to supply inclusive with the tool bar a 2KC series 2 Weigh Master, NH3 system with single central manifold and a 2KP TAPPS formulator with a single central manifold.
- 3. The top ground speed rating will be 8 mph for the rental period based on good soil conditions. Supervised applications can be made at 10 to 12 mph and approved by the Exactrix Technician.
- 4. The ECU is Deere GS-3.
- 5. The Terminal is Deere GS-2 or GS-3.
- 6. Other ECU's can be installed at the expense of the customer.
- 7. Technical manuals and operating instructions will be supplied.
- 8. The maximum performance of the system is assured with Electronic Gauges panels and Tachometers.

- 9. The Mustang Openers can be rearranged specifically at the customers expense and returned to 15 inch spacing upon rental completion.
- 10. The Openers are set to band TAPPS at a 7.5 inch depth in moist soils. Since the openers band very deep the openers are not meant for soils that are hard and dry not allowing good sealing of NH3.
- 11. The machine will be supplied for 1,000 acres at \$20 per acre.
- 12. The time line is 10 days to 20 days or sooner.
- 13. Rock damage or operator failure to comply with conditions is at the expense of the operator or the customer.
- 14. Customer will operate and maintain systems service items such as filters.
- 15. Customer will operate tool bar under common procedures explained the Exactrix Technical supervisor.
- 16. Customer responsibility is supply good ammonia tanks preferable with twin top outlet valves or valves or top outlet valves from a single 1,450 gallon or 2,000 gallon tank that have a 1.5 inch dimeter valve. Small tank valves are not recommended but can be used.
- 17. Special trailers or filling systems can be supplied at the expense of the customer.
- 18. Exactrix typically produces 12% more net margin. Test plots are encouraged and comparisons can be made with other types of openers. Exactrix will pay \$1,000 for STEEP style plots.
- 19. The rental does not include freight to the farm.
- 20. The rental does include technical support and set up assistance and monitoring of daily performance reporting to Exactrix.
- 21. The rental of the Exactrix tool bar requires \$10.00 per acre be paid prior to moving the machine to the field location.
- 22. The rental applies to the purchase at the rate of 50% and must be exercised within 30 days of the last application.
- 23. The rental program may also include test plots which in turn are paid upon successful data delivery at \$1,000 for as many plots as jointly approved.
- 24. Under no circumstances does the rental include any guarantees of yield or weather-related events that can affect the outcome of the crop.
- 25. The Exactrix Mustang Tool Bar will be available to others that would want to be custom applied with the customers tractors and the Exactrix tool bar thus the tool bar can be subleased as long as the Exactrix rental customer pays Exactrix directly and covers all expenses associated with the second customer.
- 26. Exactrix will need access to the tool bar in operation for review and inspection.
- 27. The Exactrix customer must provide immediate twenty-four hour access to load and move the machine to the next job site.
- 28. Exactrix will supply orifices and filter elements based on proper pressures and cleanup of the system.
- 29. If the operator exceeds 1,000 acres of application. A second start must occur. The Final rental payment of \$10,000 is made at 1,000 acres. The machine can then be signed for another 1,000 acres with \$10.00 per acre in advance or \$10,000 downpayment. The condition is this rental is not exclusive and may not be available due to others that have made a commitment for the machine.
